The Scholarship Committee has established the following criteria for eligibility for an individual one year scholarships in the amount of \$1000.

1. Applicant must be a New Jersey resident.
2. Applicant must be a natural or adopted descendant of a member of Disabled American Veterans of New Jersey (son, daughter, grandson, granddaughter, etc.)
3. Must be a graduating High School Senior
4. Applicant must submit an essay of no more than 500 words on:
"Old Glory, The Umbrella of World Peace"
5. Applications and essays must be typed or printed legibly and in its entirety.
6. Must provide proof of relationship and proof that veteran is a member of the Disabled American Veterans.
7. Must provide a letter of acceptance from a college of your choice. Nursing and Trade Schools eligible
8. Feel free to enclose letters of recommendation. Essays will be graded for spelling, punctuation and grammar. Be sure to mention your extra curricular activities and awards you may have received,
9. All applications must be postmarked no later than Friday, April 12, 2024.
