Dear Parents and Guardians,

I am writing to advise you that this afternoon I was notified that a student from Delran High School tested positive for COVID-19.

Pursuant to New Jersey Department of Health (NJDOH) guidelines this constitutes two or more cases at Delran High School that have been confirmed positive over 14 days without a clear connection between cases.

NJDOH closure scenarios assisted in the decision to transition Delran High School to 100% Remote Instruction <u>through</u> October 19, 2020 with the Rancocas Cohort students returning on October 20, 2020 for in person instruction and the Delaware Cohort returning on October 22, 2020.

During our transition to 100% remote instruction all student activities are cancelled, inclusive of athletic practices, athletic competition or any organized team activities of any time.

Further, all school facilities are closed to the public. All students are to quarantine, practice social distancing at all times and continue to apply sound judgement when around any people outside of immediate family members.

Below is the Delran High School schedule for October 12, 2020 through October 19, 2020. Please note that during that time we <u>will not</u> be operating on the Rancocas/Delaware Cohort structure. Rather, students will attend to classes pursuant to their assigned periods on Monday, Tuesday, Thursday and Friday. Additionally, on Wednesday they will have check-in periods with their assigned teacher as has been done since the beginning of the school year.

Students should sign in for their regularly scheduled classes using the Google Meet codes that are used for Wednesday check-ins.

Each afternoon all students are able to report to their assigned teacher for shorter check in periods, extra help, clarification, etc.

PSAT's will not take place as scheduled, however please rest assured that the school administration is currently working on an alternative and will advise accordingly.
