Cafeteria: Snacks, Instruction, Lunch (Kindergarten & 1st Grade Bilingual)

Academic At Risk (504 / Intervention and Referral Services)

Grades 1 and 2: Expansion of Concurrent Learning (streaming)

Proposal for Review: Re-Entry Phase 2

Recommended Academic Schedule: April 12, 2021

Transition to on site instruction each Wednesday: alternate cohort attendance

Recommended for Approval

Motion to revise and resubmit the *Restart and Recovery Plan* to the New Jersey Department of Education for review with the following revisions:

- Elimination of Wednesday Remote Day Effective April 12, 2021 (Appendix N - Section B.3, 2 and Appendix N - Section B.3, 8a)
- Alternating week cohort attendance each Wednesday Effective April 12, 2021 (Appendix N - Section B.3, 2 and Appendix N - Section B.3, 9)
- Consolidation to one cohort in Kindergarten Effective March 22, 2021 (Appendix N - Section B.3, 2 and Appendix N - Section B.3, 9)
- Increase of PlexiGlass barriers for Kindergarten Effective March 22, 2021 (Appendix B-Section 9C)
- Expansion of Special Education, English Language Learners and academically at risk students each day the district is open for on-site instruction effective March 22, 2021 (Appendix N - Section B.3, 6 and 9)
- Increase of outdoor tents at each school effective April 1, 2021 (Appendix H-Section 2)
