# **Plumbing Technician Position**

Reports to: Supervisor of Buildings and Grounds

## **SUMMARY:**

Perform general labor inside and outside the physical plant and help maintain the plant in a condition of operating excellence so that full educational use of it may be made at all times.

- 1. Must have a thorough understanding of commercial plumbing systems.
- 2. Preferably have worked in the field as a journeyman or minimally as a helper.
- 3. Must be able to repair all types of sewer lines including cast iron, ABS, PVC, copper and lead.
- 4. Must be able to install and repair waterlines, copper, PVC and cast iron.
- 5. Must be familiar with various methods of drain opening using snakes, pneumatic charges and chemical methods; and the practical application of such practices.
- 6. Should have a thorough understanding of flush valve repairs and adjustments. Be able to install, repair and troubleshoot all brands of faucets used in typical school buildings.
- 7. Be able to disassemble threaded piping and reassemble/repair chase threads as required to repair piping in boiler rooms and throughout the buildings.
- 8. Layout and install gas piping from schematic drawings.
- 9. Install and repair air traps on hydronic equipment.
- 10. Utilize, crossover training to repair commonly used small engine equipment, typically used in the school environment.
- 11. Must be able to work in a collaborative environment to do systematic repairs without affecting the educational environment.
- 12. Must be able to operate vehicles with snowplows, sand & salt spreaders.
- 13. Must have a working knowledge of repairing and maintaining various small engine driven equipment.
- 14. Must be proficient at identifying, diagnosing and planning methods of repairing problems that occur in a school environment.
- 15. Must possess a valid New Jersey Drivers license.
- 16. Must possess a Black Seal License.
- 17. Emergency snow removal and graduation coverage are mandatory requirements and will be scheduled as they occur.
- 18. All other duties as assigned by your immediate Manager and/or Superintendent.

## QUALIFICATION REQUIREMENTS:

To perform this job successfully, an individual must be able to perform each essential duty satisfactorily. The requirements listed below are representative of the knowledge, skill, and/or ability required. Reasonable accommodations may be made to enable individuals with disabilities to perform the essential functions.

## **EDUCATION:**

High school diploma or general education degree (GED).

## LANGUAGE SKILLS:

Ability to read and interpret documents such as safety rules, operating and maintenance instructions, and procedure manuals. Ability to write routine reports and correspondence. Ability to speak effectively before small groups of employees of organization

## **MATHEMATICAL SKILLS:**

Ability to calculate figures and amounts such as discounts, interest, commissions, proportions, percentages, area, circumference, and volume. Ability to apply concepts of basic algebra and geometry.

## **REASONING ABILITY:**

Ability to solve practical problems and deal with a variety of concrete variables in situations where only limited standardization exists. Ability to interpret a variety of instructions furnished in written, oral, diagram or schedule form.

#### **CERTIFICATES, LICENSES, REGISTRATIONS:**

Valid driver's license with a good driving record. Low Pressure Boiler License.

#### OTHER SKILLS AND ABILITIES:

Ability to pass a district written and physical test. Ability to establish and maintain effective working relationships with students, staff and the community. Ability to perform duties with awareness of all district requirements and Board of Education policies.

## PHYSICAL DEMANDS:

The physical demands described here are representative of those that must be met by an employee to successfully perform the essential functions of this job. Reasonable accommodations may be made' to enable individuals with disabilities to perform the essential functions.

While performing the duties of this job, the employee is frequently required to stand, walk, use hands and fingers to handle or feel objects, tools, or controls; and talk or hear. The employee frequently is required to reach with hands and anus. The employee is occasionally required to sit. The employee continuously uses hand strength to grasp tools and climb ladders. The employee will frequently bend or twist at the neck and trunk more than the average person while performing the duties of this job.

The employee must frequently lift and/or move up to 50 pounds such as a tool box. Occasionally the employee will lift and/or move up to 90 lbs. such as motors. The employee will sometimes push/pull items such as tables, scaffolds, and air compressors. Specific vision abilities required by this job include close vision, color vision, peripheral vision, depth perception, and the ability to adjust focus.

## **WORK ENVIRONMENT:**

The work environment characteristics described here are representative of those an employee encounters while performing the essential functions of this job. Reasonable accommodations may be made to enable individuals with disabilities to perform the essential functions.

While performing the duties of this job, the employee regularly works indoors and will occasionally work outdoors. The employee will work near or with moving mechanical equipment. The employee may work with toxic or caustic chemicals such as petroleum products, degreasers, sprays and non-household dust. The employee must be able to meet deadlines with severe time constraints. The noise level in the wok environment is usually moderate and occasionally will work in a loud area.
